Letter from the Chair and Executive Director

We focus on making their professional lives easier so they can focus on building, growing and maintaining successful practices, providing patients the best possible care.

Part of our vision for the profession is the inclusion in government programs, growing the available research, and solidifying our position in the insurance industry. All of this will help to increase the presence of massage therapy in the minds of Ontarians as a valuable health care option. None of this would be possible without the engagement and support of our members. It is thanks to our dedicated members that we can be a part of the important conversations, important decisions, and necessary actions that keep the profession of massage therapy at the forefront of health care in Ontario.

This past year, the RMTAO engaged our members to provide feedback and support to promote the benefits of massage therapy and the valuable skills of Registered Massage Therapists to the public, government, insurers, and other stakeholders. The Town Hall Meeting in Toronto and our tour across Ontario gave RMTs the chance to engage with the RMTAO in person and share their vision for the future of the profession in Ontario and Canada. We used the social media hashtag #RMTAOListens to get input from those unable to make the in-person meetings. By bringing together the variety of feedback that was provided, we were able to amplify that feedback and direct it towards the appropriate stakeholders and effectively represent the best interests of the massage therapy profession.

Massage therapy across Canada has become more united over the past several years. Working together on national issues allows us to combine our efforts to affect greater change. There are many issues that affect massage therapists in Canada regularly in their practices. By working with our national massage therapy partners, we are able to have a greater positive impact on the growth and advancement of the massage therapy profession not only in Ontario but across Canada.

The RMTAO, in its leadership role with the Canadian Massage Therapist Alliance (CMTA), is a valuable contributor for national initiatives for the profession of massage therapy. We initiated the creation and distribution of a national survey of the profession. The survey will help us to develop a clear picture of the issues that concern massage therapists at a national level and determine how best to approach those concerns to ensure that massage therapy is recognized nationally as an important part of the health care picture. Through our active leadership with the CMTA, we provided feedback to the Canadian Massage Therapy Council for Accreditation regarding their proposed accreditation standards. These standards will ensure that entry-level massage therapy educational programs across Canada are successfully training the next generation of massage therapists.

We have work ahead of us. The regulatory landscape is changing, the insurance landscape is

Town Hall Meeting

The RMTAO met with many engaged RMTs on Monday March 7, 2016 at the Allstream Centre in Toronto.

Our Executive Director, the RMTAO Board of Directors, and our engaged members got together to discuss the future of the massage therapy profession. We discussed the barriers the profession faces relating to identity, professionalism, research, awareness, collaboration and viability and brainstormed possible solutions.

were able to take questions and comments on Twitter, making this Town Hall an interactive event even for those unable to attend.

Tour Across Ontario

MVA and WSIB Cases

The RMTAO's online course, Insurance Reimbursement for Massage Therapists: Working with Auto Insurance and WSIB Cases, in partnership with Centennial College, was offered three times in 2016 to a total of 65 people.

This workshop provides a detailed overview of a massage therapist's record-keeping requirements, including all necessary documentation such as: health history, initial treatment plan and ongoing notes; key information that must be captured at every stage of the process; legal requirements for maintenance, storage and destruction.

Understanding My Rights and Responsibilities

This workshop highlights common business issues including how to handle a difficult situation with a client or colleague while still maintaining professionalism and integrity, how to effectively negotiate a contract, and what you need to know to sell your practice.

Advocacy

The RMTAO advocates on behalf of all Registered Massage Therapists

in Ontario. The RMTAO is the voice of the massage therapy profession in Ontario, and we work to ensure that the massage therapy profession is recognized, respected and viable. Our advocacy efforts have focused on collaboration with other massage therapy associations across Canada, other health professional associations in Ontario, strengthening relationships with government and the insurance industry, and other essential stakeholders.

National Advocacy

The RMTAO continues to be a valuable partner with other provincial and territorial associations across Canada as a member of the Canadian Massage Therapist Alliance (CMTA). The RMTAO has taken a leadership role in the CMTA, ensuring that the massage therapy profession has a unified voice at a national level. National advocacy initiatives pursued over the past year include:

- The creation and distribution of a National Survey of the massage profession.
- Initiation of a National Environmental Scan to get a clear picture of the landscape of the massage therapy profession at a national level.
- Consultation and collaboration with the Canadian Massage Therapy Council for Accreditation.
- Assisted in the review of CMTA bylaws and policies to ensure the CMTA continued to work for the benefit of the massage therapy profession across Canada.
- Engagement with the insurance industry regarding evidence supporting the efficacy of massage therapy as a health care option.
- Publication of an interview in Benefits Canada Magazine.

Provincial Advocacy

The RMTAO advocates on behalf of all Registered Massage Therapists in Ontario, on a number of issues that directly affect the profession at a provincial level. We have continued to build and develop important collaborative relationships with other health professional associations, government, regulatory colleges and other stakeholders. The RMTAO has undertaken several important advocacy initiatives over the past year including:

- Providing feedback to the Ontario Clinic Regulation Working Group relating to the proposed clinic regulations.
- Active participation in the Coalition Representing Health Professionals in Automobile Insurance Services to meet and provide feedback to the



Financial Services Commission of Ontario and the Ontario Ministry of Finance on the update to the Common Traffic Impairment Guidelines.

- With our partners in the Coalition Representing Health Professions in Automobile Insurance Services, provided a formal response to the Financial Services Commission of Ontario regarding the draft statement of priorities.
- Working closely with our partners at the Coalition of Ontario Regulated Health Professional Associations, on important issues of shared concern.
- Participation in consultation with the Ministry of Health and Long-Term Care regarding the Taskforce on the Prevention of Sexual Abuse of Patients and the Regulated Health Professions Act.
- Participation in the creation and development of a program of care for mild traumatic brain injury for the Workplace Safety and Insurance Board.



- Engagement with the College of Massage Therapists of Ontario to address issues of importance to the profession.
- Participation in discussions with Bone and Joint
 Canada regarding GLA:D protocol for Osteoarthritis.

Engagement with the Ontario Council of Private Massage Therapy Colleges and the Heads of Massage Therapy Programs in Community Colleges in regards to common clinical language of measurements and outcomes, interprofessional collaboration, and business training in current massage therapy program curriculae.



- Presentation to the Heads of Massage Therapy Programs in Community Colleges on the potential move to a baccalaureate degree.
- Engagement with the Ministry of Health and Long-Term Care regarding a modernization of the Regulated Health Professions Act.
- Providing support to the Prince Edward Island Massage Therapy Association regarding a Code of Ethics and Standards of Practice as they work towards regulation.
- Contribution to other health care professional association publications relating to massage therapy and interprofessional collaboration.
